### Retail Sales Index and Food & Beverage Services Index December 2024

Retail trade and food & beverage (F&B) services are integral to Singapore's domestic consumption, catering to consumers' daily needs and enjoyment. Retailers sell merchandise directly to consumers while F&B operators provide prepared food and drinks for consumption on-premises or take-away. The Retail Sales Index (RSI) and Food & Beverage Services Index (FSI) measure the performance of the retail trade and F&B services industries in Singapore respectively, based on the monthly sales of businesses (which include online sales) in these industries. The key indicators also include a snapshot of the proportion of sales conducted online.

## OVERVIEW – RETAIL TRADE

On a year-on-year basis, retail sales declined 2.9% in December 2024, following the 0.5% decline in November 2024. Excluding motor vehicles, retail sales decreased 4.0%, extending the 1.1% decline in November 2024. On a seasonally adjusted basis, retail sales declined 1.5% in December 2024 over the previous month. Excluding motor vehicles, seasonally adjusted retail sales fell 3.5% compared to November 2024.

The estimated total retail sales value in December 2024 was \$4.6 billion. Of this, an estimated 13.4% were from online retail sales, lower than the 14.7% recorded in November 2024 when there were major online shopping events. Excluding motor vehicles, the total retail sales value was about \$4.0 billion, of which 15.4% were from online retail sales. Online retail sales made up 50.9%, 33.4% and 12.2% of the total sales of the Computer & Telecommunications Equipment, Furniture & Household Equipment and Supermarkets & Hypermarkets industries respectively.

### Year-on-Year Change (at Current Prices)

Within the retail trade sector, most industries recorded year-on-year declines in sales in December 2024. The Computer & Telecommunications Equipment, Mini-marts & Convenience Stores and Wearing Apparel & Footwear industries recorded year-on-year declines in sales of between 6.7% and 13.1%.

In contrast, retailers of Food & Alcohol and Motor Vehicles recorded year-on-year growths in sales of 9.4% and 6.0% respectively in December 2024.

### Month-on-Month Change (at Current Prices, Seasonally Adjusted)

On a seasonally adjusted month-on-month basis, most industries recorded declines in sales in December 2024. Sales of Wearing Apparel & Footwear, Mini-marts & Convenience Stores and Watches & Jewellery saw declines in sales of between 6.0% and 11.6% respectively.

Conversely, sales of Motor Vehicles increased 13.2%, mainly due to higher demand for new cars. Similarly, sales of Food & Alcohol and Computer & Telecommunications Equipment grew by 2.5% and 1.0% respectively in December 2024.

## OVERVIEW – FOOD & BEVERAGE SERVICES

Sales of food & beverage (F&B) services increased 1.0% in December 2024 on a year-on-year basis, compared to the 4.0% growth in November 2024. On a seasonally adjusted basis, sales of F&B services fell 2.2% in December 2024 compared to the previous month.

The total sales value of F&B services in December 2024 was estimated at \$1.0 billion. Of this, an estimated 24.8% were from online sales, similar to the 24.7% recorded in November 2024.

### Year-on-Year Change (at Current Prices)

Within the F&B services sector, Food Caterers registered the largest growth in sales of 16.7%. Similarly, turnover of Fast Food Outlets and Restaurants increased 1.4% and 0.2% respectively during this period.

In contrast, turnover of Cafes, Food Courts & Other Eating Places fell 2.7% in December 2024.

### Month-on-Month Change (at Current Prices, Seasonally Adjusted)

On a seasonally adjusted month-on-month basis, sales of Cafes, Food Courts & Other Eating Places as well as Food Caterers decreased 3.7% and 3.3% respectively. Similarly, Restaurants fell 1.5% during this period.

In contrast, turnover of Fast Food Outlets rose 0.8% in December 2024.

## EXPLANATORY NOTES

### Introduction

The Retail Sales Index (RSI) and Food & Beverage Services Index (FSI) measure the short-term performance of the retail trade and food & beverage (F&B) services industries based on the sales records of retail trade and F&B services establishments respectively. Sales figure refers to the value of retail goods or food & beverages sold to consumers during the month, excluding taxes on products such as Goods and Services Tax (GST), Additional Registration Fee (ARF) and Certificates of Entitlement (COE).

The RSI and FSI are available at current prices and in volume terms. The indices at current prices measure the changes of sales values which can result from changes in both price and quantity, while the indices in volume terms measure the changes in the volume of economic activity by removing the price effect.

### Data Collection

Data used to compile the RSI and FSI are obtained primarily from the monthly surveys of retail trade and F&B services establishments. Retail trade establishments sell merchandise directly to the consumers, while F&B services establishments sell prepared food and drinks for consumption on premises or on a take-away basis.

### Index Compilation

To derive the RSI and FSI at detailed industry level, the monthly sales for that industry is divided by the average monthly sales for the same industry in the reference year. The overall RSI and FSI are then computed by combining the sales indices of the detailed industries, using weights which measure each industry's relative importance in the overall retail trade and F&B services industries respectively.

To derive the indices in chained volume terms, the sales indices at current prices at detailed industry level are first deflated by the appropriate price indices. These component indices are then weighted using previous years' weights to derive the overall indices in chained volume terms. The reference year of the indices is 2017.

### Online Retail and Food & Beverage Sales Proportions

The retail trade statistics covers:

- (a) (multi-channel) retailers in Singapore that sell via both physical stores and online/e-commerce sites;
- (b) retailers in Singapore that sell via physical stores only; and
- (c) retailers in Singapore that sell mainly via online/e-commerce sites.

The food & beverage services statistics covers all sales transactions of F&B establishments regardless of mode (including those transacted via food delivery platforms).

The proportion of online retail and F&B sales<sup>1</sup> out of the respective industry's total retail and F&B sales is estimated for the overall retail trade sector, selected retail industries and the overall food & beverage services sector.

### Seasonal Adjustment

Seasonal effects are observed in both the RSI and FSI as there are usually intra-year periodic variations that repeat during the fixed period of time every year. To better reflect the underlying trend of the monthly sales, both indices are seasonally adjusted to remove the seasonal effects.

<sup>1</sup> Online retail and F&B sales refers to the sales of goods where the order is received and the price and terms of sale are agreed upon via online means, e.g. through company's website, third-party websites (e.g., online marketplaces, food delivery platforms), or mobile applications, regardless of how or where the goods are delivered or collected. This excludes agreement through telephone calls, facsimile and emails. Payment may or may not be made online.
